

America's Bad Boy Country Sweepstakes

Official Rules

1. Eligibility: America's Bad Boy Country (the "Sweepstakes") is open only to legal residents of the 48 continental states of the United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. 5.
